

The Board of Directors of ANY Security Printing Company PLC

Dr. Ákos Erdős – Chairman of the Board of Directors since 1993, independent member of the body. He graduated from Janus Pannonius University at Faculty of Law. Till the end of 1987 he worked as a journalist in the field of printed and electronic press, he was the founder and chief editor of the economic political weekly newspaper, Ötlet. He is the founding owner of Láng Kiadó és Holding Rt., till 2006 its chairman - CEO. He is the majority owner and executive of the investment and consulting company, EG Capital.

Gábor Zsámboki – Member of the Board of Directors since 2005, the Chief Executive Officer of the Company since 2008, the deputy chairman of the Board of Directors since 2014. In 1984 he graduated as an engineer from the Technical College of Transport and Telecommunication and in 1992 as an economist from the Budapest College of Foreign Trade. From 1985 he was the head of the International Telephone Centre of the Hungarian Post, and from 1988 he was the head of the Domestic and International Telephone Centre. Between 1991 and 1994 he worked as the head of the Marketing Department at Matáv Rt. and between 1995 and 1999 he worked as the marketing communication and advertising manager at the General Management Office of Matáv Rt. From 1999 he was the deputy chief commercial and marketing officer of ANY Security Printing Company, from 2007 he was the deputy chief executive officer and since 2008 he has been the chief executive officer of the Company.

Tamás Erdős – Member of the Board of Directors since 2014. He graduated from Babson College in 2006 and received his MBA from New York University in 2010. He worked as a Business Analyst from 2006 at consulting company Kolaja & Partners. Starting in 2010, he held various leadership roles at robotic surgery company Mako Surgical Corp, including Digital Marketing Manager and Manager of Strategic Initiatives, continuing work at Stryker Corporation after it acquired Mako. From 2017 to 2019, he was the Chief Executive Officer at Gyomai Kner Nyomda Zrt, becoming Chairman of the Board in 2018. From 2020-2021, he was a Senior Engineer at Narvar Inc's 0 to 1 team, and since 2021 he's been the CEO of Bit Haiku LLC, a company providing technology and security consulting services.

Robert Elton Brooker III – Member of the Board of Directors as of May 1, 2023. He graduated magna cum laude with a B.A. in economics from Harvard College in 1989 and with an MBA from Harvard Business School in 1997.

From 1989 he was Director of Marketing and Service at Lehman Brothers Global Economics Inc. In 1992 co-founded New York Bagel Corporation in Budapest, which he led as co-CEO until 1995. He gained experience at Microsoft, among other companies. From 1998 he was Director of Business Development at Thingworld LLC. He was Co-founder and CEO of ICLUBcentral Inc. from 2000 to 2005, and Chairman until 2009. From 2005 to 2007, he was owner and CEO of PTOS Software, and after the sale of the company, he became a director of the acquiring company until 2010. Co-President and Co-owner of Damotech Inc. from 2010, sold his stake in 2017. Owner of WIN-911 Software from 2013 to 2021, CEO until 2015, then Chairman until 2021. He remains a member of the Board of Directors of this company. He joined ANY's Board of Directors with many years of extensive experience in IT, corporate operations and management.



Dr. Gábor Kepecs – member of the Board of Directors since 2018. In 1978 he graduated in planned economy at the University of Economic Sciences — where he took his Degree in economics in 1992 —, and then he attained a PhD in 1983.
